Got stabilized and was asked to follow up with his own GP. 8 pm, he experienced vertigo again while watching TV, along with decreased hearing in his left ear, nausea, and tinnitus. Felt like the room is moving in an anticlockwise direction.

January 18, 2022: Visited his GP nystagmus, vertigo, and tinnitus - NAD His GP suspected Meniere's disease and requested a full blood count. Diphenhydramine (antihistamine) was given 12mg×3 daily. He was referred to an ENT specialist for a definitive diagnosis and treatment...

Dear Dr. Sarah Tariq,

I am writing to refer Anthony Brown, a 48-year-old male patient of mine who presented with vertigo, nausea, vomiting, tinnitus, and decreased hearing in his left ear. His symptoms started after prolonged sitting and working on the computer, and he has a history of engaging in triathlon activities, following a vegetarian diet, and binge drinking on weekends. He has a medical history of hypercholesterolemia, hypertension, and sleep apnea.

Anthony was seen in the ED and given IV diazepam as treatment before being discharged to follow up with his own GP. He has since visited me, and I suspect Meniere's disease. I have requested a full blood count and prescribed Diphenhydramine 12mg x 3 daily as an antihistamine.

I am referring Anthony to you for a definitive diagnosis and treatment of his condition. Please find enclosed the results of his full blood count. I appreciate your expertise in this matter and look forward to your recommendations.
